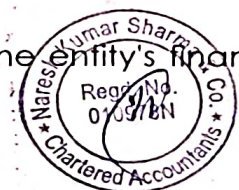
#### **Responsibilities of Management and Those Charged with Governance for the Financial Statements**

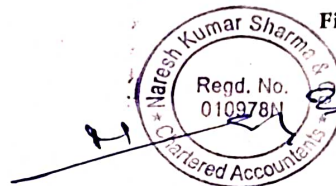

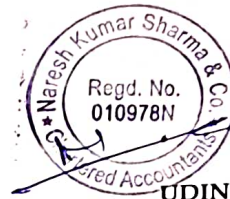


