Right to Life Foundation, Haryana Annual Report 2022-2023

Introduction

The Right to Life Foundation, Haryana, has made significant strides in its mission to promote health and wellness across the state. This annual report details the progress and accomplishments made during the period from April 2022 to March 2023, highlighting key activities and initiatives undertaken to improve community health and welfare.

Major Achievements

Field Visits and Collaborations

- **Field Visits:** Conducted extensive field visits in collaboration with representatives of the district administration, facilitating a deeper understanding of local health challenges and needs.
- **Memorandum of Understanding (MOU) with Jhajjar Administration:** On May 19, 2022, an MOU was signed with the Jhajjar administration, formalized by office order no. 93/ON dated May 17, 2022. (Copy enclosed)
- **Memorandum of Understanding (MOU) with Rohtak Administration:** On December 23, 2022, an MOU was signed with the Rohtak Administration, formalized by office order no. 20533/MB. (Copy enclosed)
- **Memorandum of Understanding (MOU) with Municipal Council, Jhajjar:** On September 6, 2023, an MOU was signed with the Municipal Council, Jhajjar, formalized by office order no. MCJ/ME/608. (Copy enclosed)

Establishment of Office and Resources

- **Office Allocation:** Secured office space and necessary human resources to support project implementation and operations.

Project Implementation in Jhajjar

- **Project Launch:** The proposed project commenced on July 4, 2022, in a customized format as per the guidance of the district administration.
- **Coverage:** From July 4, 2022, to December 31, 2022, the team covered 19 wards of Jhajjar Nagar, targeting attendees primarily from Anganwadi members of the respective wards, as well as 22 Primary Health Centres (PHCs) across 17 villages in Jhajjar.
- **Rohtak Project:** Followed successive meetings with Rohtak administration in the presence of the State CSR committee and other stakeholders.
- **Municipal Project:** Implemented immediately from the next day after the MOU signing.

Participation and Outcomes

- **Camp Participation:** A total of 1316 individuals participated in the camps.
 - **Symptomatic Observations:** 131 participants were observed to have symptoms requiring further medical attention.

- **Referrals:** 29 individuals were referred for additional investigations.
- **Counselling Sessions:** Conducted more than 250 individual counseling sessions.
- **Resident Visits:** Conducted resident visits in almost all the villages.
- **Data Collection:** Collected primary data from over 1000 participants, which is currently under analysis.
- **Community Participation:** Active community participation observed in the municipal council project.

Community Welfare Programs

- **Ongoing Activities:** In addition to the Jhajjar project, the foundation remained actively involved in various community welfare programs, attending to them as required.

Expansion to Rohtak


- **Rohtak Project:** Submitted and signed an MOU for the Rohtak project, formalized by office order no. 20533/MB on December 23, 2022.

Conclusion


